### Introduction

Placematters CIO ("we", "our", "us") respects your privacy and is committed to protecting your personal data. This Privacy Policy explains how we collect, use, store, and share your personal information when you visit www.placematters.org.uk (the "Website"), subscribe to our communications, or otherwise interact with us.

#### **Data We Collect**

We may collect and process the following types of personal data:

- Technical & Usage Data: IP address, browser type, operating system, pages visited, time on page

We do not collect any special category data (e.g. health, ethnicity, or religious beliefs), and we do not knowingly collect data from children under 16.



#### **How We Use Your Personal Data**

We use personal data only when we have a lawful basis to do so. Typical purposes and legal bases include:

- To respond to enquiries or contact requests Legitimate interests
- To send newsletters, updates, and event invitations Consent
- To manage and improve our website and services Legitimate interests
- To comply with legal or regulatory obligations Legal obligation
- To share data with partner organisations where appropriate and with your permission Consent

# **Marketing and Communications**

We will only send you newsletters, updates, or invitations if you have actively opted in to receive them. You can withdraw your consent or unsubscribe at any time by clicking the unsubscribe link in our emails or contacting comms@placematters.co.uk.

We may occasionally rely on the "soft opt-in" exception under PECR for existing contacts, where lawful.

We never sell or rent your personal data to third parties.

#### **Sharing Your Personal Data**

We may share your information with:

- Service providers (e.g. website hosting, analytics, or email delivery such as Mailchimp or Google)
- Partner organisations, only where you have given explicit consent
- Regulators or authorities where required by law

Where data is transferred outside the UK, we ensure that appropriate safeguards are in place (e.g. UK adequacy decisions or standard contractual clauses).

## **Cookies and Analytics**

Our website uses cookies and similar technologies to:

- Improve site performance and security
- Analyse visitor behaviour (via Google Analytics)
- Store your preferences and session information

Where required by law, we ask for your consent before setting non-essential cookies. You can control or delete cookies via your browser settings at any time.

### **Data Retention**

## **Data Security**

## **Your Rights**

Under the UK GDPR, you have the following rights:

- Erasure request deletion of your data
- Restriction limit processing
- Data portability receive data in a structured format
- Objection to processing based on legitimate interests or for direct marketing
- Withdraw consent at any time
